FIRE: 13 ambulance calls & 2 fire calls for June CPR Trainer Training is scheduled for August 7 Meat Raffles will start again in August 2022 and run through April 2023. All meat raffles are held on the 3rd Thursday of each month at the firehouse in Newville

PUBLIC: RD has concern regarding mowing along roadways but also a compliment for a job well done with mowing along roadways

SOLICITOR: 830 DGR – is a condemned property, qualifies as a blighted property. MM will send a letter letting them know that they cannot do anything until the septic issue is resolved and the property is inspected by Commonwealth Code. **Blue Mountain Heights** – none of the items have been submitted as requested. MM will send letter to obtain paperwork requested. **Garman Curative Amendment** – due to illness the hearing was cancelled and will be rescheduled. **19 Creekview Rd** – MM will send a letter regarding cleanup of the property JF,FO **490 Shed Rd** - property qualifies as a blighted property. Needs to get septic repairs done and bring the property into compliance with Zoning. **447 Shed Rd** – property has not been mowed. Board requests MM send a letter giving 10 days to comply or file a civil complaint JF,FO
