BOARD OF SUPERVISORS MEETING
July 31, 2025**

The Lower Mifflin Township Board of Supervisors met on July 31, 2025 for their regular meeting. Clint Barrick, Jake Fealtman, Frank Oiler were present. The meeting was called to order by CB at 7:00pm. The minutes of the June 26, 2025 meeting were approved with correction JF,FO,CB

PUBLIC: Eric Leidich (326 DGR) is having yard sales through September. He is not requesting a conditional use for a business. BOS gave him 60 days from tonight to remove the tent completely to avoid the conditional use. Derek Kramer requested a letter be sent to CC Conservation district due to his property being inspected incorrectly. The way that it was inspected combined lots which would require more permitting. His build was on his own parcel and did not require stormwater management. Letter to be sent CB,JF,FO. SG gave an FPR update from Barb Gleim's ice cream & issues event.

SOLICITOR: 524 Shed Rd – Not much success in the mortgage status with this property
85 Asper Rd – complaint is all but ready to file.
830 Doubling Gap Rd – Todd Barrick (neighboring property) won the bid and the blighted property status has been completed for that property.

ROADMASTER/ASST. ROADMASTER: DJ reported that mowing & weedwacking is completed. Mower frame is cracked and needs replaced. Rock Run Rd intersection was milled and base was applied with millings. Creekview Bridge deck replacement project is almost completed and will be opening very soon. Creekview Rd also had edges of the road milled. Turnpike culvert was repaired. Davis Duck barn paved the driveway opening as required. Creekview bridge truck traffic safety concerns – meeting with L-Tap & Rick Levan will be happening in August.
