March 21, 2024**

The Lower Mifflin Township Board of Supervisors met on March 21, 2024 for their regular meeting. Clinton Barrick, Jake Fealtman, Frank Oiler were present. The meeting was called to order by CB at 7:02pm. The minutes of the February 29, 2024 meeting were approved JF,CB,FO

EMC: 2024 Emergency Action Plan for LMT updated

PUBLIC: *John Wolfe* - presented 2024 insurance plans *Brian Garman* - presented the BOS with concerns regarding the roadway weight restrictions presented in LMT *271 Shed Rd* - questioned about what concerns were brought regarding his property. Roadmaster stated that he needed to install a driveway access with stones to prevent debris coming out onto the roadway. Driveway permit application given to resident. DG questioned how the township will handle the trimming of trees along roadways. JF wants to trim back to the trunk of the tree to open up the ROW. He also noted that signs were stolen in LMT and UMT *19 Creekview* – new owner came to discuss his plans for the property. BOS asks that the owner put in writing what his plans are. Brandi asks that it be by April 10.
