

**LOWER MIFFLIN TOWNSHIP
BOARD OF SUPERVISORS MEETING
October 27, 2022**

The Lower Mifflin Township Board of Supervisors met on October 27, 2022 for their regular meeting. Clint Barrick, Jake Fealtman, Frank Oiler were present. The meeting was called to order by CB 7:02pm. The minutes of the September 29, 2022 meeting were approved CB,JF,FO

FIRE: NFC report was presented: August – 17 calls September – 19 calls The build of the new engine has been pushed back to July of 2023

PUBLIC: RD brought complaints against the Chairman of the Board and the Zoning Officer. He demanded that 159/161 Roxbury Rd be cleaned up within 20 days or both the COB & ZO must resign. He claims neither of the men are doing anything, and have done nothing, to force the residents to clean up these properties and that the neighbor across the road from the properties has asked RD to represent him in bringing this information before the board.

SOLICITOR: 2 Meadows Rd. – hearing is scheduled for November 9 @10:15am for non-payment of trash bill
447 Shed Rd – Judgement was in favor of LMT. We will wait 30 days for appeal of the decision. **324 Mountain Rd** – New property owner is running an ag business on the property. Many neighbors were in attendance at the meeting stating that the new owner is working at all hours of the day and evening, and into the night. They are concerned about the noise and the large pieces of farm equipment being hauled in and out on township roads. MM had sent a letter inviting the new resident to attend a township meeting. He didn't show up.

ZONING OFFICER REPORT: 4 permits this month \$125.00 fees
324 Mountain Rd – No response from owner on letter from solicitor ZO asks that a fine for operating a business without permission or license along with a certified letter be sent, motion made by board to do CB,JF,FO

ROADMASTER: Special needs sign installed on Conifer Rd. 3 loads of antiskid need ordered. JF doing a roadcheck on 10/28/22 Pipeline Rd bridge replacement grant through CC was not accepted.
